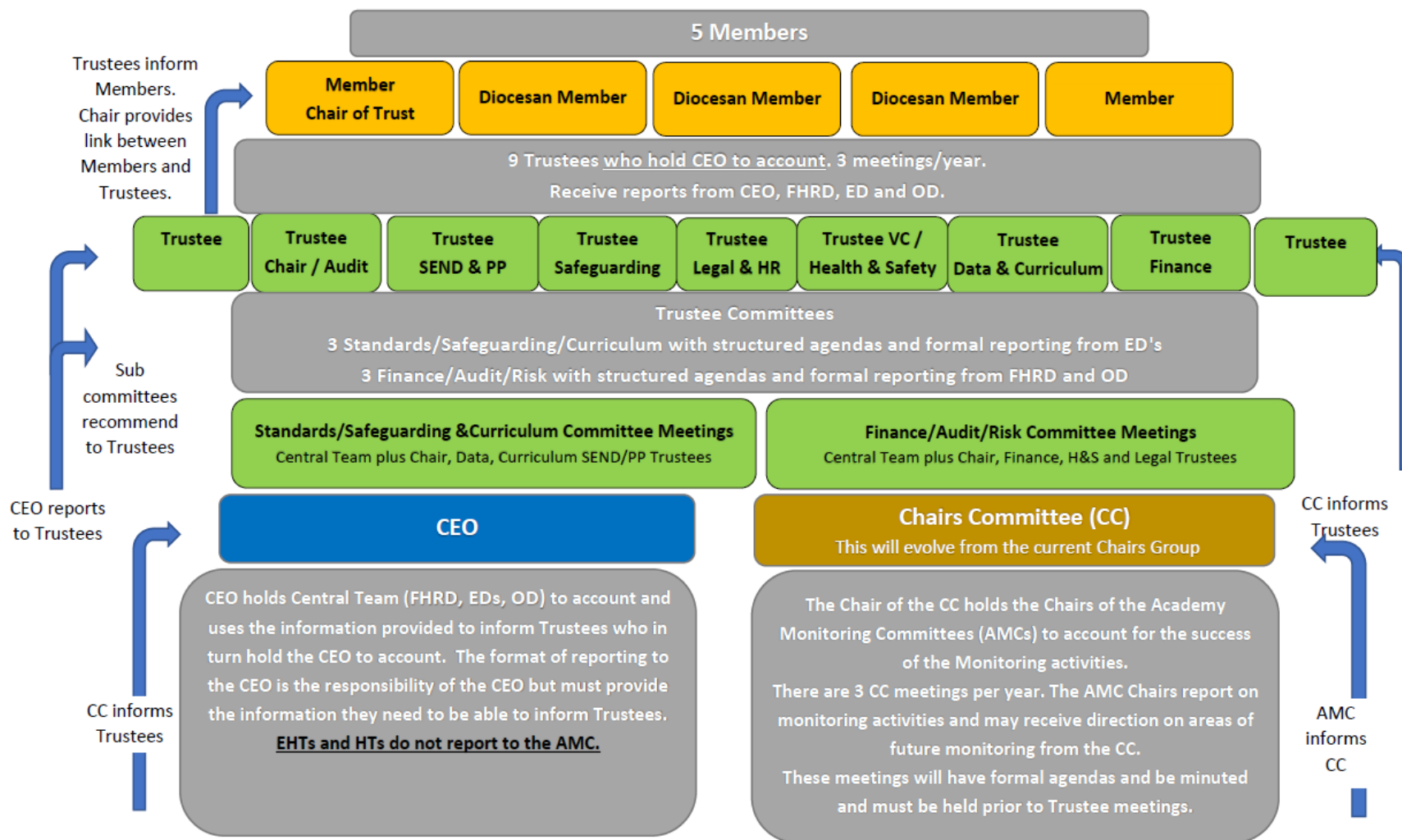

How are governors chosen?

- The Infinity Trustees are appointed by the Members.
- The Trustees elect a Chair and Vice Chair; these elections must be ratified by the Members.
- Academy Monitoring Committee (AMC) Chairs are ratified by the Trustees once elected by the AMCs. AMC governance volunteers (known as Academy Champions) are still classed as such but have been delegated only certain local aspects of governance. The Academy Monitoring Committee appoints a Vice Chair. The Vice Chair acts as Chair when the Chair is unavailable and assumes the role of Chair if the current Chair resigns between meetings. The Trustees must ratify a Vice Chair acting as Chair.
- Each Trustee/AMC member has the right to vote on each and every agenda item discussed at meetings apart from associates.
- The CEO is not a Trustee.
- Executive HT/HTs are not AMC Academy Champions although they are expected to attend AMC Briefing meetings to update the Trustees/AMC Academy Champions

Meetings

- Trustees meet a minimum of 3 times per year and consider all aspects of governance for all schools within the Trust.
- Finance, Audit & Risk Sub-Committee (FAR) meet a minimum of 3 times per year and consider Finance, Audit and Strategy issues prior to presenting the issues and potential solutions to the full Trust board.
- Safeguarding, Standards and Curriculum Sub-Committee (SSC) meet a minimum of 3 times per year and consider Safeguarding, Standards and Curriculum issues prior to presenting the issues and potential solutions to the full Trust board.
- Infinity local governance meet 6 times per year and considers all aspects of governance for their own academy and the wider Trust.
